

Mwinyi attributes one-year strides to peace

said, vowing to sustain the stance in his entire tenure in office because, "There is no way the national economy can grow in the midst of corrupt and dishonest public servants."

The President defended his dismissal of chief executives of various public institutions, saying the sacking was inevitable to infuse discipline in public service. "Most of the fired officers were either linked to embezzlement of public resources or things were just not moving in their respective institutions."

Dr Mwinyi reaffirmed his keenness to enforce accountability in public service, warning that any underperformer will be subjected to stern disciplinary measures. "We have already created an image of severe punishment for unaccountability."

He said the government has devised an appropriate development plan that focuses on the blue economy—tourism, port, fishing, oil/gas and marine transportation—to accelerate the national economic growth; "Zanzibar has limited land but is endowed with resourceful ocean."

He said in the one year period, the government has attracted huge investments, es-

pecially in tourism sector. Just last month, President Mwinyi laid foundation stones for construction of various tourist hotels, including three projects in Unguja with combined investments of 335 million US dollars (about 800bn/-).

"Huge amount of money has been invested in just a short period and many prospective investors are coming," Dr Mwinyi said, further reiterating the government commitment to implement the multibillion US dollar Mangepwani project.

According to the master plan by Oman Investment Authority (OIA), the integrated project involves construction of a multi-terminal port, satellite city and redevelopment of Malindi port as a tourism hub.

The 180-hectre satellite city whose 10 per cent is for commercial uses will accommodate 50,000 inhabitants.

"The project execution might take between three and four years but once completed, it will accelerate the national economic growth," said President Mwinyi.

The government, through the project, aims at transforming Zanzibar into East and Central Africa's commercial and tourism hub through construction of essential economic infrastructure.

Samia submits assets forms

DCEA Commissioner General Gerald Kusaya.

Addressing a press conference in Dar es Salaam yesterday, Commissioner Kusaya said out of the total suspects 2,231 were found with heroin, 502 with Cocaine, and 37,743 with cannabis while the remaining 5,308 were possessing khat.

He said the Commission confiscated 1,125.41 kilogrammes of heroin, cocaine (26.67kgs), cannabis (199,740kg), khat (97,640 kgs), precursor chemicals 57,600 kgs as well as 431kg of methamphetamine.

He explained that a total of 434,684 kilogrammes of bhang and 170,760 kilogrammes of khat were impounded between 2011 and September 2021. "This shows that there is a high consumption of bhang among all other illicit drugs, we are working hard day and night to contain the problem," he explained.

Speaking on industrial illicit drugs, Mr Kusaya said between 2011 and 2021, the Authority seized a total of 2,192.9 kilogrammes of heroin, 390.8 kilogrammes of cocaine as well as 431.02 kilogrammes of methamphetamine.

In April this year, DCEA in collaboration with the Tanzania Navy Command arrested seven Iran nationals who were ferrying 504.36 kgs of heroin and 355 kgs of Methamphetamine along the Indian Ocean in Lindi region.

The consignment was netted at Kilwa Masoko area in Kilwa District, Lindi region being ferried along the Indian Ocean in a dhow christened Al Arbo, making a record of huge packages of illicit drugs being netted at once since independence. On enforcing the Drug Control and Enforcement Act, the Authority filed a total of 6,894 cases in different courts within the country.

He said a total of 336 cases were concluded whereas the government has won 243 of them.

Other achievements that DCEA has recorded ahead of the commemoration of 60 years of independence include dissolution of a network of drug dealers.

"This has been attained through cooperation with the United Nations Office on Drugs and Crime (UNODC), Interpol, Drug Enforcement Administration (DEA) and National Crime Agency (NCA)," he noted.

He added that Tanzania has managed to curb importation of

illicit drugs by over 90 per cent.

He said Tanzania has also made huge progress in controlling irregularities in the importation of 304,513 litres of liquids and 22,143 tonnes of precursor chemicals and curbing importation of illicit drugs by over 90 per cent.

Control of irregularities in importation of precursor chemicals has enabled the country to be appointed to train nine countries on techniques on curbing importation of narcotic chemicals.

A list of countries includes Rwanda, Burundi, Madagascar, Zambia, Malawi, Ethiopia, Mozambique, Eritrea and Mauritius. Tanzania has formed a trilateral planning cell with Mozambique and South Africa on effectively fighting drug trafficking and consumption.

Apart from arresting drug dealers the Authority in collaboration with the Ministry of Health, Community Development, Gender, Elderly and Children has managed to improve provision of services to drug addicts.

"In 2011 there were three centres that were accommodating 3,500 victims but now a number of centres have increased to 11 serving 10,565 drug addicts each day," he said, adding that plans are in place to increase four satellite centres in Kigamboni, Segerea, Tageta and Mbagala in Dar es Salaam region.

PRESIDENT Samia Suluhu Hassan has continued to lead by example after she recently became among the first public leaders to submit the Assets and Liabilities Declaration Form to the Ethics Secretariat.

Commissioner of the Ethics Secretariat Judge Sivangilwa Mwangesi told reporters yesterday that President Samia submitted the form at the Ethics Secretariat's sub-head office in Dar es Salaam on November 29, 2021.

"President Samia handed in her declaration form on November 29, 2021 at the Secretariat's sub-head office in Dar es Salaam and was received here on Thursday (December 2nd, 2021)" said the Ethics Commissioner.

He said according to the laws, public leaders are supposed to submit the assets and liabilities forms every year between October 1 and December 31, of the respective year.

Justice Mwangesi said more than 15,000 public leaders are supposed to sign and submit their assets and liabilities declaration forms but only 161 had done so until the end of last month.

He said by becoming among the first public leaders to fill in and submit the form to the Ethics Secretariat President Samia has shown the public she is indeed lead-

ing by example, calling upon the remaining public leaders to emulate the example.

Justice Mwangesi said public leaders who are yet to fill in and submit the forms should not wait for the deadline as the last-minute rush results into unnecessary inconveniences.

According to the regulations, he said, those who fail to submit the assets and declarations form within the scheduled time will have to appear before the Ethics Council for further actions.

Justice Mwangesi said last year all public leaders with an exception of one person submitted their assets and liabilities declaration forms within the deadline.

However, thorough search conducted revealed that the leader had duly submitted the form only that it was unintentionally misplaced.

He cited some advantages of such facilities to the public, including reducing costs and time spent by citizens in seeking justice, as well as lowering administrative and court operating costs.

"There are five IJCs in Dar es Salaam, Morogoro, Mwanza, Dodoma, and Arusha, and most of the court buildings were old because they had been there even before independence," he explained.

According to him, court buildings in the past were old and dilapidated but as the nation celebrates 60 years of independence, there are various modern court buildings and the best courts that are not only the best in Tanzania but also a role model in the African continent.

Prof Gabriel stated that the number of courts has increased at all levels; there are 17 High Court centres, 4 High Court divisions, 29 Resident Magistrate Courts, 120 District Courts, and

960 primary courts.

The IJC is a one-stop centre so they provide all judicial services in one area, from the Primary Court to the Court of Appeal. The Primary Court, District Court, Resident Magistrates' Court, High Court, and Court of Appeal are among them.

On the use of Information Communication Technology (ICT), he remarked that since the colonial era, all court records were being written by hand, which has resulted in delays in the administration of justice.

The Court has installed sophisticated technological systems. "Our team is collaborating with outside experts to ensure we get a software architect for translating Kiswahili and other languages, including native ones," he said.

Procedures for recording court hearings, registration of proceedings, and updates in the Judiciary Statistical Dashboard System (JSDS II), e-library and website use, e-office, and the

The Head of State noted that since the country needs more investors then it is crucial for government officials to act accordingly for the greater interest of the nation.

She was also pleased to learn that the factory has already received a tender to connect 185 district councils and 4,580 wards with fiber optic cable to ease communications and development.

"The connectivity project will require only 12,000 kms of optic fiber cable out of the factory's annual capacity of 24,000 kms. This is a huge step towards supporting local investments," stated President Samia.

According to her, the government recognises and appreciates the contributions of the private sector in building the economy, and that efforts are underway to improve the Blue Print for Regulatory Reforms to Improve the Business Environment.

She also expressed the government commitment of ensuring Information and Communication Technology (ICT) service is availed across the country.

President Samia also challenged the owner of the industry, Mr Ramadhan Mianzi to fulfill his dream of building a smartphone manufacturing factory, a move that will further efforts of

digitising the economy.

She said the government will continue building infrastructures to support the industrial sector in the Coast region in continued efforts to create employment opportunities and facilitate transfer of technology, including spurring the country's economic growth.

"We shall ensure adequate supply of water, electricity and good road network to ease investment and business as well as movement of people, goods and service to and from the region," she added.

Earlier, Minister of State in the Prime Minister's Office (Investment) Geofrey Mwambe described the establishment of the factory as a key achievement for the country since independence of 1960.

"This project was registered in 2015 by then I was Director General of Tanzania Investment Centre (TIC), I helped him (the investor) in addressing challenges he was facing on establishing this factory," he explained.

He also commended the CRDB Bank for loaning the investor to a tune of 22bn/- that has played a great role to establish the plant.

Going forward, the minister invited investors to make better use of available opportunities as the government has worked on challenges that were hindering the investment sector.
